Regarding: Long Grass on Golf Course

This note is intended to update you on the boarder grass areas at the StoneWater CC golf course. A few years ago, we let the boarder areas around the golf course grow naturally longer to allow for better-defined golf holes. After year one, we responded to feedback and cut back several areas. Over the last two years we have continued to reduce the areas that have long grass while improving the golf course playing conditions for our golf members.

Last year, 2022, we again reduced about 30% more of the long grass from the course. This year, 2023, we plan to reduce the sprinkling in the remaining long grass areas, so the grass will not get as thick and tall. Also, we plan to increase the mowing from 2 times per year to 3 times in these areas so the grass will not get as matted and overgrown.

While we cannot please everyone with our approach to how we manage our boarder grass, we do feel these final improvements will make a positive impact. StoneWater unlike other community golf courses, have large border grass areas that are not normally in play for the golf course. Letting these areas go natural does add some nice look and dimension to the open spaces and help define and accentuate the golf course appearance.

We hope you can see the advantages of having a successful golf club as your neighbor. We will continue to invest into the property and facilities to keep your and our investment at its best.
